27 November 2003 Mariupol

WERE PRESENT:

President - Chairman of the Azov Department of Academy of economic sciences and enterprise activity, Chairman of Civil International Committee (CIC), academician of Academy of economic sciences of Ukraine, academician of Academy of economic sciences and enterprise activity of Russia, academician of the New York Academy of Sciences, member of a Research Board of the Advisers of the American Biographic Institute, member of International Biographic Center of Cambridge, Doctor Valery Alexandrovich Vasiljev;

Vice-chairman of the Azov Department of Academy of economic sciences and enterprise activity, Vice-chairman of Civil International Committee (CIC), academician of the New York Academy of Sciences, Honorary Member of Academy of economic sciences and enterprise activity of Russia, member of the AAAS, member of a Research Board of the Advisers of the American Biographic Institute, Dr econ. PROBLEM

Account (CIC) of the sponsor's help to Civil International Committee on preparation of a world(global) public opinion in realization of the First World Congress of a Spiritual Unification.

LISTENED: the assistant of the Chairman of the Azov separation of Academy of economic sciences and enterprise activity, assistant of the Chairman of Civil International Committee, Dr Alexander Vasiljev, which one has said following: "Dear colleagues, November 22, 2003 in the

newspaper "The PriAzov Worker" published the article "92 problems had taken ill a condition of health of the ex-director of branch "Privat bank" (From a court-room) ". In this article a problem on absence of perspectives to the former investors "Privat of bank" again mounted to receive assigned by the director of the Mariupol branch "Privat of bank" dollars in the sum of 4 million 886 thousand. I do not want to retell the contents of the article, which one all of you read, but I address your attention to negative only consequences for any currency score in Mariupol "Privat bank" of this information. This information became property practically of all news agencies due to the publication in "The PriAzo's Worker". Say to me, who after that will enumerate means from distant foreign (West Europe, America) countries in Mariupol in "Privat of Bank"? This first on what I address your attention.

Second, December 29, 2000 of Warsaw by me listed(transferred) sponsor's means to the currency score of the Azov Department of AES&E. This operation executed(designed) due to a positive estimation of our activity by the sponsors of Poland, which one have considered acceptance and first outcomes of fulfilment of the program " the Red data book of Europe " (Reports №№ of 1,3,5 Azov Department of AES&E), and also first concrete steps on creation of a historical-cultural complex "Bowery - Catholic" (Solution Topolinsky of agricultural Advice № XXIII -1373 from 20.04.2000) and proposal of the vice-president of the Azov Department of AES&E on International scientific conference in Warsaw "Integration European, processes of a globalization and situation of edges(boundarice) of Europe by Eastern " (October 20-21 2000). The professor of Institute of Political sciences of the Warsaw University Rushard Brozgynjak, director of Institute of the food equipment the Pan Gruhelsky and farmer a Pan Brama with large thanks was accepted by(with) copies of the score about listing 70 dollars to account of the Azov Department of AES&E on December 30 2000. However, on January 3, 2001 me have called in Bank of Warsaw and appealed for(asked) to indicate number of the agreement, according to which one the listings were by me are made. I have indicated number of the agreement number 3 from December 28, 2000, which one was signed for all sponsors by the professor of the Warsaw University Rushard Brozgynjak. It is the agreement required(demanded) as well in Mariupol "Privat of Bank", which one was transferred(handed) to them in January by 2000 President chairman of the Azov Department of AES&E, academician of Academy of economic sciences of Ukraine Valery Vasiljev. But 25.09.2003 these agreements it was not revealed in materials of the Azov Department of AES&E in the Mariupol branch "Privat of Bank", also in 2002 was straightened out(found out), that money from Warsaw has acted(arrived) to account of the Mariupol branch "Privat of Bank" only on January 5, 2001. All this calls(causes) bewilderment, and main - we can not risk AUTHORITY of Civil International Committee. Therefore I offer:

- 1. To introduce change to the solution of a managers of the Azov Department of AES&E and Civil International Committee from November 15 2003 on point of discovery of the score Civil International Committee and to consider(count) the currency score of the Azov Department of AES&E only as accumulative score for the sponsors of Eastern Europe.
- 2. To appeal for(ask) any organization in West Europe temporarily to undertake accumulation of means from all sponsors of Civil International Committee before discovery of the score of Civil International Committee in Bank of Renovation and development in Western Europe.
- 3. To appeal for(ask) all members of Civil International Committee to state concerning this initiative.

HAVE ACTED: President - chairman of the Azov Department of AES&E, Chairman of Civil International Committee, academician AES of Ukraine and New York of an Academy of Sciences, Dr Valery Vasiljev, which one has said: "We owe have made GRATITUDE of the First Vice-Chairman CIC Dr Ernesto Garsia for large confidence to us as to the experts in a sector of the economy. I think the today's solution will allow him will be convinced, that we sincerely aim to provide all most negative moments, which one can damage to authority of our public organization. We are grateful Dr Ernesto Garcia for acceptance of our proposal on discovery of HONORARY pages CIC, in which one the information on our sponsors (Personal,

Public Organizations, Commercial Companies and Businessmen) will be reflected. We are obliged to express thanks to monogynopaedium of Dr Ernesto Garsia for actual sponsorship of the project of a INTERNET - PAGE of our Committee. I offer to centre attention on creation of the first open estimate of Civil International Committee, which one the friends in Spain agree to place on Internet - page CIC.

HAS ACTED: Scientific secretary of Institute of Economical - Socio-cultural Researches and Azov Department of EAS&E Marina Tuzovskaya, which one has said: "We should accept these changes for maintenance of reliance(confidence) of the sponsors in America in target consumption of their means, which one they will agree to enumerate to address Civil International Committee. You see the law on mandatory sale of 50 percents of currency receipts(entries) in Banks of Ukraine while is distributed to all public organizations. We should not overlook(forget) about it. Also I offer to enter into a structure of scientific advice of Institute of Economical-Socio-Cultural Researches and in a structure of scientific advice of the Azov Department of AES&E of the engineer Victor Anatoljevich Chopovsky instead of leaving Anatoly Vasiljevich Shtepa (anticipatory measure; the condolence is sent till the Internet to mail for publication). Look your attention, that Victor Anatoljevich Chopovsky already was preformed a thesis on competition of a honorary academic rank " by the doctor of commerce " and only formalities because of necessity of licensing of each banking operation with Russia detain issue of the doctoral diploma.

- **1.** To introduce change to the solution of a management(manual) of the Azov Department of AES&E and Civil International Committee from November 15, 2003 on point of discovery of the score Civil International Committee and to consider(count) the currency score of the Azov Department of AES&E only as accumulative score for the sponsors of Eastern Europe.
- **2**. To appeal for(ask) any organization in West Europe temporarily to undertake accumulation of means from all sponsors of Civil International Committee before discovery of the score of Civil International Committee in Bank of Renovation and development in Western Europe.
- **3.** To express on behalf of Presidium the Azov Department of AES&E, scientific advice of Institute of Economical Socio-Cultural Researches and Civil International Committee
